

The Parties to this Deed are:

- (1) **THE SECRETARY OF STATE FOR EDUCATION** of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**"); and
- (2) **GIPPESWYK COMMUNITY EDUCATIONAL TRUST** (formerly known as Copleston High School) a charitable company incorporated in England and Wales with registered company number, whose registered office is at Copleston High School, Copleston Road, Ipswich, Suffolk, IP4 5HD (the "**Academy Trust**")

together referred to as the "**Parties**"

INTRODUCTION

- A. The Parties entered into a Funding Agreement for the purposes of a single academy on or around July 2011, this was amended by a Deed of Variation dated 12 April 2013 (the "**Existing FA**").
- B. The Company now intends to operate more than one academy.
- C. The Parties therefore have agreed to amend and restate the terms of the Existing FA, in accordance with the terms of this Deed, to form a multi academy trust.

LEGAL AGREEMENT

1. Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Master Funding Agreement (as defined in clause 2 below).
2. The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing FA shall be amended and restated in the form of a new agreement which shall consist of the terms of the Master Funding Agreement contained in Schedule A (the "Master Funding Agreement") and separating other provisions into a corresponding Supplementary Funding Agreement contained in Schedule B (the "Supplemental Funding Agreement").

GOVERNING LAW AND JURISDICTION

3. This Deed, and any dispute or claim arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims) shall be governed by and interpreted in accordance with the law of England and Wales.
4. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, this Deed or its subject matter or formation (including non-contractual disputes or claims).

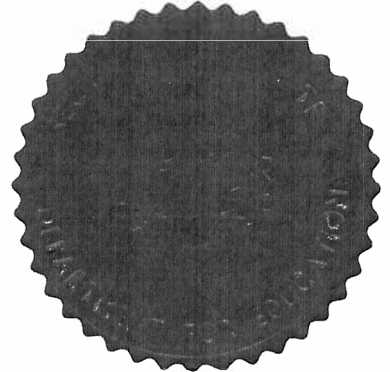
COUNTERPARTS
